Types of publications

Publications published by the Publishing House of the Polish Naval Academy include:

- monographs (monographs, handbooks, scripts, lexicons, dictionaries and other);
- continuing resources;
- other publications necessary to perform the duties of the university.

Planning

- 1. The basis for the performance of publishing activities is the publishing plan of the Polish Naval Academy, which is drafted separately for each calendar year. It includes all positions which the organizational units of the Polish Naval Academy intend to publish in a specific year.
- 2. The publishing plan is approved by the Vice-Rector of Science after seeking the opinion of the Chancellor.

Requirements concerning publications

- 1. A computer typescript and an electronic version of the publication together with minutes and opinion of the competent academic discipline council shall be delivered by the author (co-authors or scientific editor of a group publication) within the time limit provided for in the publishing plan.
- 2. The computer typescript and electronic version of the publication delivered by the author (co-authors or a scientific editor of a group publication) must be:
 - identical;
 - complete main body of the text must be drafted and delivered along with any attachments (footnotes, references, indices, illustration descriptions, etc.) and appropriately placed figures;
 - final their content cannot be changed in terms of subject-matter, publishing aspects or formal and organizational aspects by the author (co-authors or a scientific editor of a group publication) upon their delivery to the Publishing House.
- 3. Authors (co-authors or an editor of a group publication) prepare the publication in accordance with "Guidelines for Authors".

Code of publishing ethics

- 1. The Publishing House has an independent and impartial publishing policy.
- 2. The Publishing House ensures compliance with ethical, intellectual and editorial standards.
- 3. The Publishing House places special emphasis on the compliance with ethical principles by authors, reviewers and other persons related to publishing works.

- 4. A publication submitted to the Publishing House must be original, previously unpublished and the rights of the author to the publication cannot be in any way limited.
- 5. By signing the publishing agreement, the author (co-author or a scientific editor of a group publication authorized by authors in writing) transfers copyrights to the publisher the Polish Naval Academy.
- 6. If fragments of another publication protected by copyright are used in the work submitted for publication (in whatever form, e.g. text, tables, figures), the author shall specify the sources of fragments cited (used) in the work (submitted article) and, in situations stipulated by the provisions on copyright, perform formalities arising from the relevant act, including deliver a written consent of the copyright owner to the use of materials.
- 7. Responsibility for the payment of a fee, if any, for the consent of the copyright owner to the use of materials rests with the author.
- 8. Authors sign a statement regarding the contribution of co-authors.
- 9. Ethical standards and measures to prevent fraud in publishing practice applied by the Publishing House are consistent with Committee on Publication Ethics (COPE) guidelines available at https://publicationethics.org/files/Full%20set%20of%20Polish%20flowcharts.pdf

Reviews

- 1. All monographs are subject to review.
- 2. Reviewers are appointed by the Vice-Rector of Science after seeking the opinion of the competent leader of the academic discipline.
- 3. Reviewer nominations are presented by the competent academic discipline council which recommends the work for publication.
- 4. Each work is reviewed by two independent reviewers.
- 5. Reviews are made by external reviewers (from outside the Polish Naval Academy). If there are no representatives of a specific field of science to which the work pertains outside the Polish Naval Academy, the competent academic discipline council presents reviewers from the Polish Naval Academy.
- 6. Reviewer submits a written statement on non-existence of a conflict of interests between them and the author.
